PROGRESS ANNOUNCEMENT POSSIBLE ACQUISITION OF ALL THE SHARES IN THE CONTROLLING SHAREHOLDER BY GEELY GROUP LIMITED

Reference is made to the announcements of the Company dated 11 January 2005 and 7 February 2005 respectively (the “**Announcements**”) regarding the Possible Acquisition. Terms used herein shall have the same meanings as defined in the announcement of the Company dated 11 January 2005.
