The Board is pleased to announce that the resolutions proposed at the EGM held on 6 December 2021 at 4:00 p.m. were duly passed by the Independent Shareholders as ordinary resolutions by way of poll.

Reference is made to the circular regarding the Continuing Connected Transactions (the “**Circular**”) and the notice of the extraordinary general meeting (the “**Notice**”) of Geely Automobile Holdings Limited (the “**Company**”) both dated 16 November 2021. Unless the context otherwise requires, capitalised terms used in this announcement shall have the same meaning as those defined in the Circular.

**POLL RESULTS OF THE EXTRAORDINARY GENERAL MEETING HELD ON
6 DECEMBER 2021 AT 4:00 P.M.**

The board of directors (the “**Board**”) of the Company is pleased to announce that at the extraordinary general meeting of the Company held on 6 December 2021 at 4:00 p.m. (the “**EGM**”), the resolutions as set out in the Notice were approved by the Independent Shareholders as ordinary resolutions by way of poll in the manner prescribed under Rule 13.39(4) of the Listing Rules. The Company’s Hong Kong share registrar, Union Registrars Limited, was appointed as scrutineer for the vote-taking at the EGM.

As at the date of the EGM, Geely Holding is beneficially wholly owned by Mr. Li and his associate and Mr. Li, Mr. Yang Jian, Mr. Li Dong Hui, Daniel and Mr. An Cong Hui are directors of Geely Holding. Mr. Li, Mr. Yang Jian, Mr. Li Dong Hui, Daniel and Mr. An Cong Hui, each an executive director of the Company, are considered to be interested in the Continuing Connected Transactions by virtue of their interests and/or directorship in Geely Holding. As at the date of the EGM, Mr. Li and his associates together holding 4,042,618,000 Shares (representing approximately 41.16% of the total issued share capital of the Company), Mr. Yang Jian and his associates together holding 6,000,000 Shares (representing approximately 0.06% of the total issued share capital of the Company), Mr. Li

Dong Hui, Daniel and his associates together holding 4,504,000 Shares (representing approximately 0.05% of the total issued share capital of the Company), and Mr. An Cong Hui and his associates together holding 7,526,000 Shares (representing approximately 0.08% of the total issued share capital of the Company), had abstained from voting at the EGM.

As at the date of the EGM, the Company had 9,821,136,540 Shares in issue. Independent Shareholders holding a total of 5,760,488,540 Shares were entitled to attend and vote for or against the resolutions at the EGM. Save for the above, there were no Shares of holders that are required under the Listing Rules to abstain from voting at the EGM. There were no Shares entitling the holder to attend and vote only against the resolutions at the EGM.
