GRANT OF SHARE OPTIONS

This announcement is made pursuant to Rule 17.06A of the Rules Governing the Listing of Securities (the “**Listing Rules**”) on The Stock Exchange of Hong Kong Limited (the “**Stock Exchange**”).

The board of directors of Geely Automobile Holdings Limited (the “**Company**”) announces that on 2 June 2015, the Company granted 21,400,000 share options (the “**Share Options**”) to 14 eligible grantees (the “**Grantees**”) under the share option scheme of the Company adopted on 18 May 2012 which, subject to their acceptance of the Share Options, will entitle them to subscribe for a total of 21,400,000 new shares of HK\$0.02 each (the “**Shares**”) in the share capital of the Company. The grant of the Share Options to the Grantees is intended to provide them with incentives or rewards for their contribution to the Company and its subsidiaries, in particular on product research, development and design. Details of the Share Options granted are as follows:

Date of grant (the “ Date of Grant ”)	: 2 June 2015
Exercise price of the Share Options granted	: HK\$4.08 per Share
Number of Share Options granted	: 21,400,000
Closing price of the Shares on the Date of Grant	: HK\$4.02 per Share

The Share Options are valid for a period of 5 years from 2 June 2015 to 1 June 2020 and their vesting period is set out in the following table:

Between 2 June 2017 and 1 June 2018 (the “ Third Period ”)	Up to 25% of the Share Options together with any Share Options not exercised during the previous periods will be exercisable during the Third Period
Between 2 June 2018 and 1 June 2019 (the “ Fourth Period ”)	Up to 25% of the Share Options together with any Share Options not exercised during the previous periods will be exercisable during the Fourth Period
From 2 June 2019 until the expiry date of the Share Options	Up to 25% of the Share Options together with any Share Options not exercised during the previous periods will be exercisable from 2 June 2019 to the expiry date of the Share Options

No Share Options will be exercisable after their expiry date.

The exercise price of each Share Option is HK\$4.08, which represents the higher of (i) the closing price of HK\$4.02 per Share on 2 June 2015, being the Date of Grant of the Share Options, and (ii) the average of the closing price of HK\$4.08 per Share as stated in the daily quotation sheets issued by the Stock Exchange for the five business days immediately preceding the Date of Grant.

None of the Grantees is a director, chief executive or substantial shareholder of the Company, or an associate (as defined in the Listing Rules) of any of them.
